Ms. Pratt is a graduate of the Massachusetts College of Art, Boston, Studied under Rutledge Bate, Fenway Studios; Charles Mahoney, Ellis House, Scituate; and Jack Callahan. She is an accredited instructor at the South Shore Art Assoc., Lexington Arts and Crafts Assoc., Copley Society of Boston, Falmouth Art Guild and the Pastel Society of America, N.Y.C. Ms. Pratt has received many awards including the Gold Medal award at the Catherine Lorillard Wolfe Art Club, the Gold Medal Award at the Academic Artists Association, the 1980 award from the Salmagundi Club, N.Y.C., the 1979, 1980 awards from Springfield Art League and others. She enjoys gallery affiliations in New York, as well as Boston, and the South Shore. Ms.Pratt has been featured in the following publications; "Drawing with Pastels" by Ron Lister, Prentice-Hall, Inc. Frontispiece for "Concerning the Art of Poetry" by Wilmon Brewer, Marshall Jones Company, and is featured in the October 1984 issue of the American Artist magazine.
